a. Review of Action Items:

- b. Approval of October 6, 2016 Meeting Minutes & March 23, 2017, Meeting Notes:
 - No quorum, therefore, approval of Minutes and Notes deferred to next meeting.

4. Old Business:

- a. Protected Areas Update:
 - Ongoing.
- b. 76 Johnson Road Update (BG):
 - HRM and Halifax Water follow-up site visits:
 - Halifax Water completed a site visit in January 2017. Clean-up by owner is slowly progressing. The HRM clean-up order remains in effect until the site meets compliance; and
 - The owner requested an extension due to an accident he recently suffered.
- c. Lake Major Regulation changes/considerations:
 - i. Dam Upgrade (BG)
 - Halifax Water applied to and received approval from the province to amend the *Lake Major Watershed (LMW) Protected Water Area (PWA)* Regulations to allow for an outboard motor larger than 9.9 horse power (hp) for water utility-related business;
 - This regulation change does not affect the public, who are permitted to use up to a 9.9 hp motor within *LMW PWA*.

ii. On-site septic systems (BG)

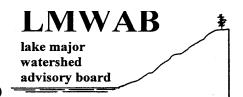
- Halifax Water is responsible for monitoring and enforcing activities with respect to the *PWA* regulations inside the *LMW PWA*. The most efficient way to enact its responsibilities is for Halifax Water to be aware when risky activities take place, which is common practice. However, exceptions occur, particularly when private onsite septic systems are installed within the *PWA*. Halifax Water is seeking improvement in NSE's notification practices, considering it is the responsible agency with respect to approving on-site septic system installations.
- Halifax Water received a response letter from NSE (to Halifax Water's letter dated: February 27, 2017, circulated at the March 23, 2017 LMWAB meeting) indicating that the Municipality (in this case Halifax Water) is responsible for enforcing respective *PWA* regulations, to which Halifax Water acknowledges.
- However, the LMW PWA Regulations fail to identify NSE as the agency responsible for issuing approvals for on-site sewage disposal system (OSSDS) installations within the PWA, which creates a communication gap for the responsible agency

• Halifax Water is preparing a response letter to NSE, including a request to meet with the Wastewater District Manager to discuss improvements in the approval/notification processes with respect to OSSDS applications within *PWA*s.

iii. Swimming in Long Lake

- At the September 30, 2015 meeting, PC, on behalf of the North Preston Ratepayers Association (NPRA) made a request to Halifax Water to begin talks about allowing swimming in Long Lake.
- Halifax Water sent a letter to the NPRA asking to meet, at the Association's convenience, to discuss the options available to further consider their request.
 - o Awaiting response to the letter.

d. Source Water Protection Plan Update:

- To expedite the review process, the DRAFT Source Water Protection Plan (SWPP) was submitted to NSE in April 2017;
 - To review the SWP Plan, LMWAB members may access it <u>online</u> at https://www.halifax.ca/sites/default/files/documents/home-property/water/LakeMajor-SWP-Plan.pdf or by request to Halifax Water.
- BG explained that the SWPP defines the history, geology and land use of watershed area; identifies the risks to the watershed area; explains what Halifax Water monitors for and how it manages the risks; and provides an implementation plan timeline.

5. New Business

- a. North Preston Recreational Field (BG):
 - HRM submitted plans to Halifax Water to develop and build a Recreational Field on land owned by Halifax Water in the community of North Preston.
 - O Halifax Water forwarded the plans to the Lake Major Watershed Advisory Board for review in June 2017. The following comments were received and forwarded to HRM:
 - To comply with Section 15(4) of the *LMW PWA* Regulations, an erosion and sedimentation control plan must be developed and approved in writing by NSE, following consultation with the Board; and
 - Section 16(1) restricts road construction to between June 1st and September 30th, inclusive, in any year. However, the construction project involves more than just road construction. HRM indicated that the construction activities will likely fall outside of the June 1st-Sept. 30th timeframe due to federal funding restrictions which require all federal spending to be completed by March 31, 2018. Halifax Water advised HRM to contact NSE for clarification regarding whether section 16 applies to the construction activities planned.

- o The project has not started.
- NSE has not indicated whether construction activities will be permitted outside of the restricted timeframe.

Action: Halifax Water to contact NSE to determine whether HRM has been approved to work outside of the road construction timeline window as per Section 16(1) of the LMW PWA Regulations.
