She also introduced Kenda MacKenzie, Director, Regulatory Services and Jamie Hannam, Director, Engineering and Information Services. Ms. Miller and Mr. Gray gave an executive summary of the Regional Development Charge update. The proposed water RDC increased as a result of more robust, comprehensive water modelling, improved data and a review of infrastructure requirements.
