4.1 OPERATING RESULTS FOR THE ELEVEN MONTHS ENDED FEBRUARY 29, 2020

A report dated March 18, 2020, was submitted.

Louis de Montbrun gave a brief overview of the Operating Results, followed by a brief discussion, including anticipated impacts of the current pandemic.

4.2 2020 SPRING DEBENTURE

A report dated March 16, 2020, was submitted.

Louis de Montbrun stated that the timing of the Spring debenture has been deferred until mid-June.

MOVED BY Commissioner Zurawski, seconded by Commissioner Rollings that the Halifax Regional Water Commission Board:

- 1. Approve the financing of \$25,000,000 for a ten-year term with a twenty-year amortization schedule and an all-inclusive rate not to exceed 5.5%.
- 2. Approve the financing of \$1,700,000 for a ten-year term with a ten-year amortization schedule and an all-inclusive rate not to exceed 5.5%.

5. <u>CAPITAL PROJECTS</u>

5.1 LAKE MAJOR DAM REPLACEMENT – ADDITIONAL FUNDING

A report dated March 10, 2020, was submitted.

Jamie Hannam gave a brief overview of the Lake Major Dam Replacement Project and the reasons for the additional funding required.

MOVED BY Commissioner Hendsbee, seconded by Commissioner Zurawski that the Halifax Regional Water Commission Board approve \$1,330,000 in additional funding for the Lake Major Dam Replacement Project for a total estimated project cost of approximately \$9,120,000.

5.2 <u>PORT WALLACE WATER TRANSMISSION MAIN - MAIN STREET TO CALEDONIA ROAD</u>

A report dated March 10, 2020, was submitted.

MOVED BY Commissioner Hendsbee, seconded by Commissioner Rollings that the Halifax Regional Water Commission Board approve the Port Wallace Transmission Main – Main Street to Caledonia Road project construction phase at an estimated cost of \$6,190,000 for a total estimated cost of \$6,310,000.

5.3 HEMLOCK RESERVOIR CONSTRUCTION

A report dated March 3, 2020, was submitted.

MOVED BY Commissioner Walker, seconded by Commissioner Zurawski that the Halifax Regional Water Commission Board approve funding in the amount of \$8,160,000 for the construction phase of the Hemlock Water Reservoir on Masthead Court in Halifax for a total project cost of \$8,410,000.00.
