Have your say on the Regulatory Review Process for the Lake Major Watershed Protected Water Area

In 2021, the Lake Major Watershed Advisory Board (Board) was approached about inconsistencies in the Lake Major Watershed Protected Water Area Regulations (Regulations). These Regulations are specific to the provincially designated Lake Major Watershed Protected Water Area (PWA). Through the Lake Major Watershed PWA Regulations, the Board, comprised of stakeholders and community representatives, was established to advise the Minister and the Water Works Operator (Halifax Water) on managing the Lake Major watershed. The utility (e.g., Halifax Water) is responsible for enforcing the *PWA* regulations under their jurisdiction, as directed by the Province of Nova Scotia, which includes approving any changes or amendments to their respective *PWA* regulations. Halifax Water is responsible for managing the municipal water supplies for the Halifax Regional Municipality, which includes three *PWAs*, one of which is the Lake Major Watershed.

Upon review of the Lake Major Watershed PWA Regulations, the Board agreed that there were inconsistencies and subsequently recommended that Halifax Water make a formal request to the province to amend the Regulations. Halifax Water met with Nova Scotia Environment and Climate Change (NSECC) in early 2022 to discuss the regulation amendment process, including public consultation.

NSECC directed Halifax Water to conduct the consultation and include the Board and representatives from the province. These public engagement sessions (see the table below) are designed to inform and seek input from the public on potential amendments to the Regulations.

After initial comments have been gathered, the public will be able to review the recommended Regulation amendments via Halifax Water's website until January 19, 2023. The proposed amendments will be submitted to the province by the end of January 2023.

To get started on the public consultation process, the public is invited to carefully review the *PWA* Regulations at the link referenced on the opposite page, and the tabled list (below) of some watershed-related activities, how they are currently regulated and some highlighted inconsistencies within the Regulations.
