Lake Major Watershed Protected Water Area Regulation Review Progress

In our last Lake Major Watershed Newsletter—Winter 2023, Volume 15 Issue 1, found at <u>Lake MajorNewsletterWin-</u> ter2023forLMWAB.pdf (halifaxwater.ca)—

Halifax Water provided an update on the status of the *Lake Major Watershed Protect-ed Water Area* (LMWPWA) Regulation review process. This newsletter provides details on the outcomes of that process and what to expect next.

Final Review Phase

Halifax Water wishes to thank everyone who participated in the *LMWPWA* Regulation review process, so far. The comments generated in the first community engagement phase have been carefully considered and reflected in the first draft of the revised *Lake Major Watershed Protected Water Area* Regulations, which can be found online at halifaxwater.ca/LMWPWA.

The final community engagement opportunities involve a second round of public engagement sessions, the schedule for which is listed in the table on the right. These inperson and online sessions include a presentation, followed by a question and answer period, where Halifax Water and the Nova Scotia Department of Environment and Climate Change representatives will be on hand to answer questions about the proposed changes. Also, Lake Major Watershed Protected Water Area landowners will receive a communication package in the mail providing the current Regulations and proposed revisions, along with the supporting rationale, and how to provide comment.

will be recorded and considered in the final draft of the *LMWPWA* Regulation revisions.

The proposed changes provide clear and consistent legislation that improves the public's knowledge of the Regulations and Halifax Water's ability to evenly apply the protective measures across the Designated *Lake Major Watershed Protected Water Area.* The proposed changes can be viewed online at <u>halifax-</u> <u>water.ca/LMWPWA</u>.

Submission to Nova Scotia Environment & Climate Change

Once the final public engagement review phase is complete, Halifax Water will submit the proposed *Lake Major Watershed Protected Area Regulations* revisions to the Minister of Environment and Climate Change for review and approval.

Designated Lake Major Watershed Protected Water Area

Lake Major is the primary drinking water supply for the Dartmouth region including the communities of Cherry Brook, East Preston, Lake Loon, North Preston and Westphal. The **Map on the back page** illustrates the Designated *Lake Major Watershed Protected Water Area* —outlined in red.

All lands and watercourses within the Designated *Protected Water Area* are subject to the *Lake Major Watershed Protected Water Area* Regulations, which Halifax Water is legally responsible to enforce.


