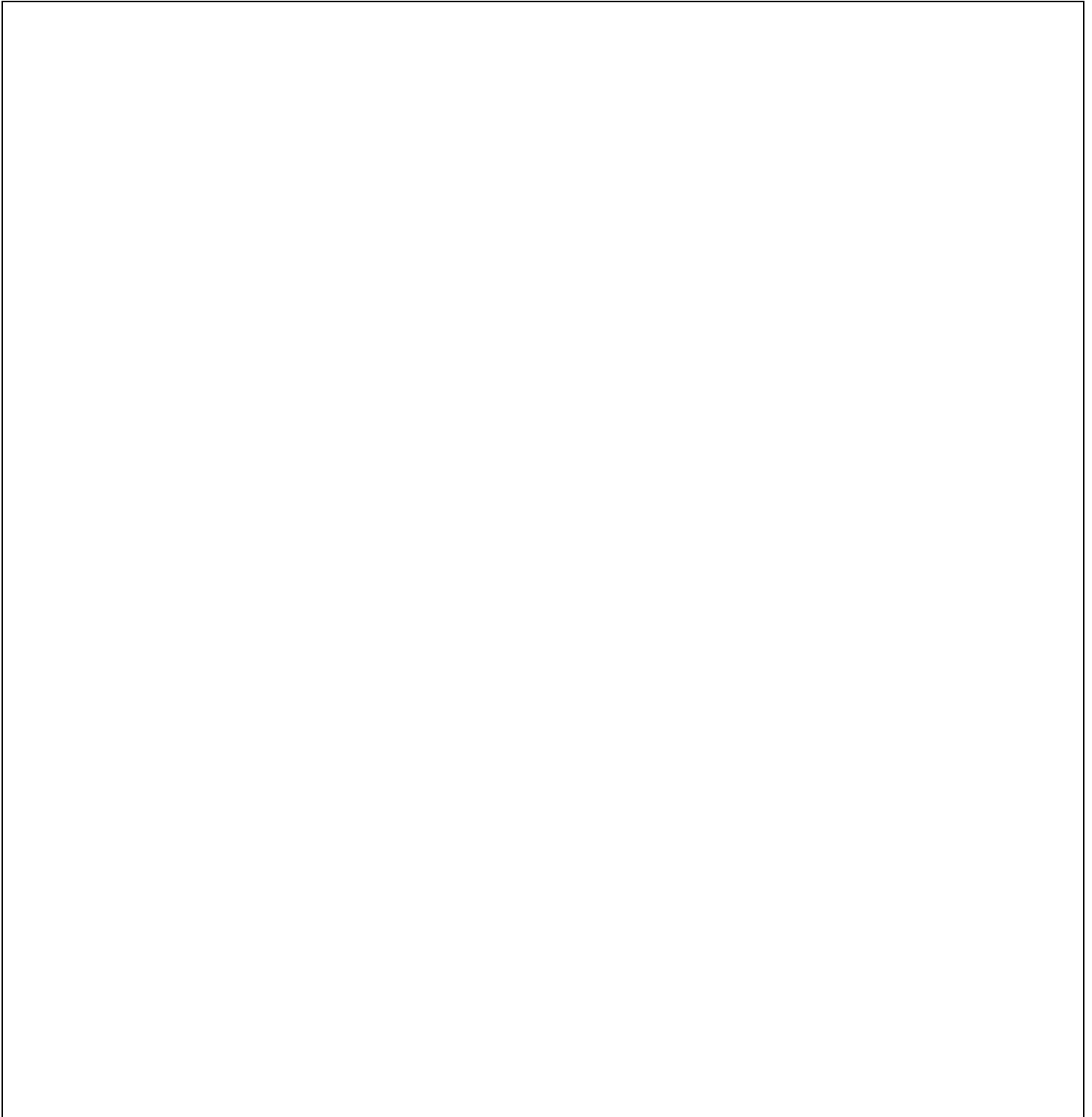

## CONSTRUCTION SITE DEWATERING APPLICATION

**DEWATERING CONDITIONS**

- You will be contacted by Halifax Water once your application is submitted in full, to obtain any additional information.
- The applicant must submit an initial representative water sample to an accredited laboratory immediately upon water being present. **AGAT and Bureau Veritas are local accredited laboratories.** If you wish to use another laboratory, please discuss with Halifax Water.
- Dewatering will not be permitted until sample results are received by Halifax Water and the dewatering approval letter has been issued. Sampling requirements vary depending on geographic location, receiving system, etc. Contact Halifax Water to determine the specific sampling and analysis requirements.
- Historical sampling (i.e., from previous work on the site, or groundwater monitoring wells) should be submitted with your application.
- Any odours, discolouration, sheen, or significant sediment noted in the water during sampling or dewatering must be reported immediately to Halifax Water and dewatering shall be suspended until the issue can be resolved.
- Ongoing monitoring and sampling will be required during dewatering activities.
- **Where applicants are directed to dewater to a wastewater or combined system, there is a charge of \$2.259 per cubic meter. You will be required to install a flowmeter, or record pump rate and duration. This will be discussed with you prior to approval.**
- There may be more site-specific conditions that Halifax Water will discuss with you during the application process.
- Approval to dewater to Halifax Water's system will be **withdrawn** if the requirements outlined in the approval letter are not met.
