## NOTICE OF PUBLIC HEARING

**IN THE MATTER OF AN APPLICATION** by the **HALIFAX REGIONAL WATER COMMISSION** for approval of amendments to its Schedule of Rates and Charges and approval of its Regulations respecting Rates and Charges for the provision of water, public and private fire protection, wastewater services, and stormwater services. The matter will be considered in a public hearing as follows:

## Board Hearings are open to the public and you may participate as follows:

- You may speak at the hearing. You must notify the Board by Monday, August 25, 2025.

- You may request formal standing as an Intervenor, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by Tuesday, May 20, 2025, and a copy of your written evidence by Thursday, July 24, 2025.

## ADDITIONAL INFORMATION:

The proposed range of rate increases for water and wastewater services depends upon the meter size and the volume of water consumed.

For a 5/8" meter, primarily residential customer, the proposed increases for water and wastewater services total 15.8% in 2025/26 and 17.1% in 2026/27.

Proposed increases for all other metered sizes for water and wastewater services range from 19.9% to 23.3% in 2025/26 and from 20.6% to 24.5% in 2026/27.

For non-residential property customers receiving stormwater service, the current site related flow charge per m<sup>2</sup> of impervious area of \$0.173, is proposed to increase to \$0.216 in 2025/26 and to \$0.277 in 2026/27.

For residential property customers receiving stormwater service, the site related flow charge is based upon an impervious area tiered rate structure. The proposed annual increase in the tier rates range from \$5.00 to \$28.00 in 2025/26, with a further annual increase ranging from \$6.00 to \$40.00 in 2026/27.

All of the above increases are proposed to become effective on January 1, 2026 for 2025/26 and on April 1, 2026 for 2026/27.

The Application further proposes various fee adjustments and administrative changes, including changes to definitions, to Halifax Water's Regulations. The fee adjustments include amendments to fire protection charges, and the stormwater Right of Way (ROW) Charge charged to Halifax (HRM), the Province and the Halifax Dartmouth Bridge Commission.

Upon reviewing the Application, the Board, in its decision, may determine that the proposed amendments should be approved as requested, or higher, or lower.
